### PARMA, OHIO

The City of Parma has taken steps to combat the opioid epidemic, including retaining Napoli Shkolnik PLLC and partnering with local hospitals to provide naloxone, a life-saving opioid overdose antidote, to police officers and first responders.

## Trial Date Set in Florida Community's Toxic Coal Ash Litigation

**Decades of contamination** of residents' homes, school and park have resulted in a stigma of the neighborhood, decrease of property values and bodily injury.

After more than a decade-long legal battle, residents of Lincoln Park will be represented in Broward County Circuit Court by Napoli Shkolnik PLLC attorneys in the fall.

Due to the former incinerator site in their neighborhood, the community has higher than average rates of cancer, including lung, prostate and liver and other medical conditions such as Parkinson's Disease and adult onset type II diabetes that have been scientifically linked to incinerator ash.

"This community's day in Court is a long time in the making. The City has known about the dangers and hazards of incinerator ash since at least the 1980's and they should be held accountable for the health problems and property damages it caused," says Partner Louise R. Caro.

Partner Hunter J. Shkolnik was named Co-Liaison Counsel in the Flint Water Crisis Litigation by United States District Judge Judith E. Levy of the United States District Court for the Eastern District of Michigan.

In this role, Mr. Shkolnik will oversee all currently pending

individual personal injury, property damage, and wrongful death cases, as well as the over 18,000 potential cases awaiting to be filed in this mass action arising out of the water contamination in Flint.

The decision comes just over three years after the water crisis in Flint began. The lawsuits allege that Flint residents suffered ruinous damages to their health and property when Defendants recommended, approved, and caused Flint's water supply to become contaminated with corrosive lead and bacteria. Napoli Shkolnik has been involved in this lawsuit from the beginning and has played a leading role in organizing, prosecuting, and coordinating the actions.

## A FIGHT TO CLEAR THEIR NAMES

**Eric Smokes and David Warren** spent years behind bars after being convicted of murdering and robbing a 71-year old French tourist in the late 1980's. Today, with Napoli Shkolnik Civil Rights attorneys Craig Phemister and James Henning on their side, the duo are looking to vacate the guilty verdicts against them.

From the beginning of the investigation, Smokes said he was uneasy with how the detectives were handling the case. He was falsely painted as the ringleader of a gang of Brooklyn robbers. Warren adds that the police and prosecutors tried to get him to implicate his friend in the crime but he never did because it was simply not true. Unfortunately, a jury did not believe them and Smokes was sentenced to 25 years to life in prison and Warren received 15 years to life.

Now their attorneys Phemister and Henning have filed a motion to vacate their guilty verdicts largely based on witnesses who have recanted. According to the lawyers, some trial witnesses made up their stories to satisfy investigators while some were promised preferential treatment on their own pending criminal cases in exchange for their testimony.


Smokes and Warren say they do not harbor anger or ill will towards those who testified against them. However, they hope that those who lied will now find the courage to come forward and admit the truth.

## NAPOLI SHKOLNIK PLLC WINS BIG LEGAL BATTLE IN NORTH CAROLINA UBER CASE



**Uber is a popular alternative** to traditional taxis for riders. It has more than 600,000 drivers in the United States but many of those drivers feel the company's rules and demands are too restrictive. Therefore the drivers feel that they should be provided the benefits of traditional employees, something that Uber challenges. Their ongoing legal battle to be classified as employees as opposed to independent contractors recently won a tentative victory.

The Federal District Court for the Middle District of North Carolina granted conditional certification to a class-action lawsuit that was filed on behalf of several UBER drivers under the Fair Labor Standards Act (FLSA).

"The ruling today is going to allow drivers across the country to band together to challenge Uber's misclassification of them," said Paul B. Maslo, a lawyer for the plaintiffs and a partner with Napoli Shkolnik PLLC. "They are employees and should be getting minimum wage and overtime as required by federal law."
