## RECOVERING MONEY FOR TREATING CONTAMINATED DRINKING WATER



**C**LEAN DRINKING WATER and unadulterated sources from which to draw that water are essential to public health. In recent years, it has become commonplace to hear of contamination of public water supplies as a result of industrial activities including hydraulic fracturing (hydro-fracking) and the run-off and discharge of toxic chemicals from industrial sites. Once a source of drinking water has become tainted by such chemicals it is often too late to completely cure the problem. For this reason, it is incumbent on municipal water suppliers and water districts to take pro-active and immediate actions to be sure that monitoring is in place to immediately identify contamination from any source and that once contamination of the water supply is found, the source of the contamination is identified and remediated and further impact to drinking water supplies is prevented.

Thus, early detection through regular testing and routine inspections of our water sources are critical to ensuring the public's safety. Maximum Contamination Levels ("MCLs") are in place to limit the level of contaminants permitted in our drinking water supply. Unfortunately, however, this safeguard is not always enough to prevent unacceptable levels of contaminants from entering our water supply. When that happens, a water district must implement treatment and remediation plans. If no treatment or remediation plan is successful, a water district may even have to find an alternative water source.

Since at least one half of the U.S. population relies on groundwater as a source of drinking water, groundwater remediation efforts are very important. A lengthy and costly remediation of contaminated water can cause a water district a substantial amount of money.
